



Beacon Pool Swim Academy Summer 2018 Swim Lessons



Beacon Recreation is excited to offer Dutchess County Residents free swim classes at the University Settlement Camp pool. All Classes are American Red Cross Learn to Swim Level I & Level II. Class size is limited. Please only enroll if you intend to attend all classes. Program runs either Tuesdays and Thursdays or Wednesdays and Fridays for two weeks (4 classes) over the course of the summer. Classes are 30 minutes in length and will focus on safety, fun and swimming fundamentals. These classes are for participants new to swimming with an emphasis on gaining confidence and learning how to be safe around water.

Parents of children ages 3 and older should plan on remaining present in the University Settlement pool picnic area for the duration of the lesson. Please note, these classes are free to all **DUTCHESS COUNTY** residents and funded in part by NYS OCFS and Dutchess County DCFS Division of Youth Services.

To register, you must apply in person at the Rec Center, located at 23 West Center Street. Enrollment is first come, first serve and class size is limited. Each participant is able to take one set of classes. The dates are as listed, there will be no make-up classes in the event of cancellation or absence.
